

# HYBRID WATERPROOF RESILIENT FLOORING

## **MANUFACTURER'S LIMITED WARRANTY**

Manufacturer warrants to the original end consumer, the Hybrid Click flooring boards for a period of Lifetime Limited Warranty from the original date of purchase. The decor surface of the boards will not wear through; the boards will not significantly fade from normal amounts of sunlight or normal artificial lighting. The boards will resist stains and are free from manufacturing defects.

Limited Water Proof Warranty - The structural integrity of the product will not be significantly diminished by exposure to water during the Limited Warranty Period under normal residential use conditions. This Limited Warranty extends only to topical moisture and topical water exposure. Please note that this limited warranty relates only to the purchased product itself and does not warranty your subfloor, residence or any other items or properties will be safe from water damage because of the installation of this product.

Limited Pet Stain Warranty - For 24 hours, the product will resist staining and damage caused by vomit, urine, and feces of domestic pets that occur during normal residential use. Please note that this limited warranty applies only to the product itself and does not warranty your subfloor, residence or any other items in your property.

11. Radiant Heat - This Limited Warranty does not cover any products installed over radiant heat that are not installed according to the radiant heat manufacturer's guidelines or not installed in compliance with the Installation and Care Requirements.

The limited warranty is subject to the following conditions: This guarantee applies only to the original purchaser and proof of purchase is required for all claims. The guarantee is for replacement or refund of the flooring material only, no labor, incidental materials, installation, removal or otherwise. This limited warranty does not cover any mouldings, accessories or building materials associated with installation, removal or replacement. This limited warranty only covers the original materials purchased and does not cover any labor costs associated with installation removal or replacement. The warranty does not cover chipping or impact marks ( flooring will chip if sharp objects are dropped on it), warping (**Flooring** will warp if subject to excessive heat), shrinkage (flooring will shrink if exposed to cold).
